

## SEARCH WARRANT AFFIDAVIT

THE STATE OF TEXAS  
COUNTY OF DENTON

THE UNDERSIGNED AFFIANT, BEING A PEACE OFFICER UNDER THE LAWS OF TEXAS AND BEING DULY SWORN, ON OATH MAKES THE FOLLOWING STATEMENTS AND ACCUSATIONS.

Your Affiant is a Police Officer, licensed by the State of Texas, and employed by the City of Lewisville Police Department. During your Affiants employment, he has conducted investigations where people that have commit criminal offenses have use cell phones devices including emails, text messaging, instant messaging, internet searches, and used cell phones to plan and to share information related to the offense. It has also been learned that the same type of devices are used for research, planning and concealment of the offenses.

**A. THIS SUSPECTED PLACE IS IN CHARGE OF AND CONTROLLED BY EACH OF THE FOLLOWING NAMED PARTIES TO WIT:**

*The custodian of records with Sprint PCS cellular telephone company.*

**B. IT IS THE BELIEF OF AFFIANT THAT AT THE SUSPECTED PLACE THERE WILL BE FOUND PROPERTY AND ITEMS CONSTITUTING CONTRABAND AND INSTRUMENTS USED TO COMMIT CRIMINAL ACTS IN VIOLATION OF THE LAWS OF TEXAS. SUCH PROPERTY AND ITEMS WILL CONSIST OF THE FOLLOWING:**

**The search of said cellular telephone stored records may include the examination of installed software; that is, digital information that can be interpreted by a computer and any of its related components, which may be stored in electronic, magnetic, optical, or other digital form. The search includes the examination of stored materials, media, documents, and data, including but not limited to: address books; recently called numbers; recently received numbers; voice mail; digital images; text messages; and GPS coordinates of incoming and outgoing calls/text messages. The search may also include the examination and/or utilization of any manuals and documentation which may be written, recorded, printed, and/or electronically stored material which explains or illustrates how**

**to configure or use the cellular telephone or other related items. The search may also include other areas of the cellular telephone in which said suspected party may store data evidence which is the object of the search requested herein. Furthermore, said items can be analyzed by a trained evidence recovery specialist in order to retrieve, restore, and/or reproduce any or all information believed to be evidence of said offense(s).**

**C. AFFIANT HAS PROBABLE CAUSE FOR THE SAID BELIEF BY REASON OF THE FOLLOWING FACTS, TO WIT:**

On April 26, 2010, Lewisville Police Officers Cassels and Lunsford were dispatched to the 1000 Block of Shadow Wood Lane in regards to an unknown problem. Officers were advised by Lewisville Police dispatch that a postman, later identified as Jeremiah Gonzalez had called and advised that he could see a body laying in the street and it appeared mutilated. He further stated that he thought the bottom part of the body was covered with a blanket. While Officers were enroute, he further advised that he could see blood in the doorway of the front door to 1020 Shadow Wood Lane and that the front door was open.

Officer Cassels arrived on scene to find a decapitated body lying in the street, along the curb line, in front of 1024 Shadow Wood Lane. The white female was lying on her stomach. The light blue pants she wore were tattered and torn and the female did not appear to have a shirt on, only a black bra. The female's head was laying about a foot to the south of the body, near the curb. The female was later identified as Maria Santos Corona.

Upon Officer Cassels arrival she also noticed another white male and white female, both Hispanic, near a vehicle that was parked facing southbound along the curb line, in front of 1020 Shadow Wood Lane. The white female, later identified as Maria 'Carla' Corona, was crying hysterically and kept saying, "That's my mom! That's my mom!"

The male with Carla Corona was identified as Freddie Arrellano who is her husband. Arrellano stated "Jose did this" (Jose is the victim Maria Corona's husband Jose Fernando Corona). Arrellano explained that he, Carla his wife, Jose Corona and the deceased Maria Corona all live at 1020 Shadow Wood Lane with their children. Arrellano was leaving to pick up his daughter at school when Jose Corona asked his daughter Carla if she would go with her husband Arrellano as Jose needed to speak with his wife Maria Corona and did not want anyone around. Carla agreed and the two left to pick up their daughter. Arrellano stated that as they were driving home he (Arrellano) received a phone call from the target phone number 214-529-1236 which he knows to belong to Jose Corona. When Arrellano answered the phone Jose Corona told him "I did it. I killed her. I'm dragging her body next door to the black neighbor's yard". Arrellano stated that they

drove straight home and found Maria Corona dead in the street in front of their neighbors house.

WHEREFORE, AFFIANT ASKS FOR ISSUANCE OF A WARRANT THAT WILL AUTHORIZE THE SEARCH OF SAID SUSPECTED PLACE FOR SAID PERSONAL PROPERTY AND SEIZURE OF ~~THE SAME~~ .

## SEARCH WARRANT

To any Peace Officer of the State of Texas, **GREETINGS:**

**WHEREAS**, the Affiant whose name appears on the affidavit is a Peace Officer under the laws of Texas and did heretofore this day subscribe and swear to said Affidavit before me and whereas I find that the verified facts stated by Affiant in said Affidavit show that Affiant has probable cause for the belief expressed therein and establish the existence of proper grounds for issuance of this Warrant.

Now, therefore, you are commanded to enter the suspected place described as:  
*Sprint PCS Custodian of records*

And to there search for, seize, conduct a forensic analysis and bring before me the personal property described below:

**The electronic storage data of target telephones 214-529-1236; from the service provider; Sprint PCS. To include, any/all electronic stored text, dialed, incoming/outgoing, photographic images, stored from the target telephones, from April 25, 2010 until Present (April 29, 2010).**

Further, you are ORDERED, pursuant to the provisions of Article 18.10, Texas Code of Criminal Procedure, to retain custody of any property seized pursuant to this Warrant, until further order of this Court or any other court of appropriate jurisdiction shall otherwise direct the manner of safekeeping of said property. This Court grants you leave and authority to remove such seized property from this county, if and only if such removal is necessary for the safekeeping of such seized property by you, or if the provisions of Article 18.10, T.C.C.P. otherwise authorize such removal. You are further ORDERED to give notice to this Court, as a part of the inventory to be filed subsequent to the execution of this Warrant, and as required by Article 18.10, T.C.C.P., of the place where the property seized hereunder is kept, stored and held.

HEREIN FAIL NOT, but have you then and there this Warrant within three days, exclusive of the day of its issuance and exclusive of the day of its execution, with your return thereon, showing how you executed the same, file in this court.


